● Declaration of Conformity

We hereby declare that the above Packaging complies with the applicable requirements of Regulation (EU) 2025/40 on Packaging and Packaging Waste (PPWR).

This Declaration is issued under the sole responsibility of the Manufacturer and is based on the Packaging Technical Documentation prepared and maintained by the Manufacturer.

Applicable Requirements and Compliance Status

The compliance status of the Packaging is as follows:

● Restrictions on Substances (Article 5)

It has been confirmed that the aggregate concentration of heavy metals (lead, cadmium, mercury, and hexavalent chromium) does not exceed 100 mg/kg.

It has further been confirmed that this packaging does not contain any "substance of concern" as defined in Article 2(27) of Regulation (EU) 2024/1781 (ESPR), the definition of which is applied by reference under Article 3 of the PPWR.

This packaging is therefore considered to comply with the applicable requirements of Article 5 of the PPWR.

● **Recyclability (Article 6)**

The applicable technical requirements and assessment methodologies have not yet been fully established.

Accordingly, a formal conformity assessment has not yet been conducted.

The required assessment will be performed by the applicable implementation deadlines established under the PPWR.

● **Minimum Recycled Content in Plastic Packaging (Article 7)**

Based on the packaging specification and weight composition assessment, the total weight of plastic components represents less than 5% of the total packaging weight.

Accordingly, the Packaging is considered to qualify for the applicable exemption under Article 7 and the minimum Recycled Content requirements are therefore Not Applicable.

● **Packaging Minimisation (Article 10)**

A formal conformity assessment has not yet been completed. However, the Packaging has been designed with consideration for product protection, logistical efficiency, and safety, and measures have been taken to avoid excessive Packaging.

The required assessment will be performed by the applicable implementation deadlines established under the PPWR.

● **Reusability (Article 11)**

The Packaging is not designed for reuse, and no collection and reuse system exists for the Packaging within the applicable distribution chain.

Accordingly, the requirements relating to reusability are considered Not Applicable.
